### **New Business**

New state legislation Lucille discussed a recently introduced bill, SB 556, that will have a public hearing next Tuesday, March 29, at the Oregon legislature. The bill would require veterinarians to report rabies vaccinations to animal control. This appears to be the only bill still active in Oregon's legislature this year.

<u>Polk County Animal Control Shelter</u> Lucille introduced Polly & Ship Schultz with Dallas Animal Control and Eric Byler with Shelter NW. Shelter NW has made a proposal to the Polk County Commission to operate the shelter Polk County is planning to build this summer. Eric's group would use volunteers and donations to operate the shelter, work for placement of dogs who cannot be reunited with their masters and give more presence at the shelter than currently planned by the County. Shelter NW will make a presentation to the Animal Control Board next week.

Discussion of how SFKC may help in this endeavor. Eric will provide additional information to the board about his organization and plan for operating the shelter.
