Introduction of Sonya Pulvers (Marion County Dog Services) by Sally Lawson. The Marion County Dog Shelter has been around ~ 9 years. Not same as Humane Society (lost dogs only). They process all dog licenses, two control officers, 100 active volunteers, ~ 1800 lost dogs per year, 48% return rate to owners. +30% adoption, euthanasia for medical need and aggression.

Explanation of Senate Bill 6 - I.e. dealing with situations such as the Brooks Shelter.

Needs - collars, leads, toys, towels, blankets, canned dog food, peanut butter.

Policy to hold lost dogs 3 days with no ID, micro chip/ID 5 day hold.

Dogs are considered "personal property".
