- 7. Members have the right to veto a judge being hired only at the breed level.
- 8. No club members of SFKC shall be hired to judge by the club. Only on an emergency basis as defined by AKC.

9. Specialty Coordinator – Chris Cameron is seeking independent, concurrent, and supported entries from specialty clubs for our shows.
